- **Players may enter two events...one singles and one doubles.**
- Draws will be posted at Fig Garden Swim & Racquet Club and The Stringer on Thursday, March 4th by 5:00 PM.
- Please report to the tournament desk at least 15 minutes before your first match.
- Players are responsible for being on time for all matches (the 15 minute default rule will be strictly enforced).

- Proper tennis attire must be worn (no tank tops for men, cut-off shirts or black soled shoes).
- All matches will be best 2 out of 3 sets, regular scoring, 12-point tiebreaker at 6-all.
